NOTICE TO VOLUNTEERS REGARDING CONSUMER REPORTS

Thank you for your interest in serving as a McCoy Federal Credit Union Volunteer. Because of our responsibility to our membership, we require anyone who volunteers to consent to a consumer credit report investigation.

If you make a written request within a reasonable period of time after receipt of this disclosure, McCoy will provide the name, address and telephone number of the reporting agency and the nature and scope of any consumer report request will be disclosed within five business days.

Before adverse action is taken based on a consumer report, you will be notified of the adverse action and will be provided with a copy of the report; the name, address and telephone number of the reporting agency; and a summary of your rights under the Fair Credit Reporting Act, including the right to dispute the accuracy or completeness of the report with the consumer reporting agency.

I hereby authorize McCoy Federal Credit Union to obtain consumer credit reports as described, and authorize any consumer reporting agencies to submit information or opinions of myself, including data received from other sources, in order that my volunteer qualifications may be evaluated. I hold said persons and/or organizations harmless and without liability for statements or opinions made about me in compliance with the Fair Credit Reporting Act.

In addition, by signing below, I certify that I am a current member of McCoy Federal Credit Union in good standing for at least 6 months or longer.
